Upgrading of Divisional Hospital – Bandarawela as a Base Hospital and maintain the quality health services by affiliating with the Base Hospital - Diyatalawa

There was a long-term need to improve the facilities of the Divisional Hospital - Bandarawela in Badulla District, which is administered under the Uva Provincial Ministry of Health, in order to meet the higher demand for its health services.

02. Accordingly, the services of Eye Unit, Dermatology Unit, Ear-Nose-Throat Unit (depending on the availability of anesthesiologist's service) Psychiatry Unit etc. initially proposed to be established in the Base Hospital – Diyatalawa. However, these facilities could not be established there due to its limited space and therefore, these facilities were proposed to establish in the premises of Divisional Hospital – Bandarawela. A Medical Unit and a Paediatric Unit will also be established in this hospital.

03. The Uva Provincial Council and the Ministry of Health have decided to provide these services by Divisional Hospital – Bandarawela affiliating with the Base Hospital – Diyatalawa, in order to meet the healthcare needs of its people as well as tourists. Accordingly, this is to inform that the Divisional Hospital - Bandarawela will be upgraded as a Base Hospital and named as the Base Hospital - Diyatalawa / Bandarawela by affiliating with the Base Hospital- Diyatalawa, and the Ministry of Health of Uva Provincial Council will take appropriate steps to administer this hospital under the Medical Superintendent and Deputy Medical Superintendent.
