**Re: Changing the Administrative Authority of Beruwala, Darga Town and Aluthgama Hospitals**

Base Hospital (Type B) – Baruwala, Divisional Hospital (Type B) – Darga Town and Divisional Hospital (Type C) – Aluthgama are currently functioning under the purview of Teaching Hospital (TH) – Kalutara. Since the scope of the TH-Kalutara is increasing, it is difficult to facilitate these hospitals properly by TH – Kalutara. These hospitals are located in the area of National Institute of Health Sciences (NIHS), Kalutara and provided secondary and primary health care services to the population of the area. The NIHS is the national level training institute for public health and field practice also.

Considering the above facts and the need for improving and streamlining the primary health care facilities of the area, the Ministry of Health has taken a policy decision to change the administrative authority of the above hospitals with immediate effect as follows:

1. To function BH – Beruwala as an independent institution and until the facilities are developed (infrastructure, cadre, finance etc.), it is proposed to get the administrative and accountancy services from the TH – Kalutara.
2. To hand over the administration of DH – Darga Town and DH – Aluthgama to the NIHS, Kalutara. This includes staff and all physical resources (land, buildings, plant / machinery, equipment and furniture).
