First efficiency Bar Examination for the primary Nontechnical Service Category PL - 01 - 2006 (A) In the Ministry of Health & Indigenous Medical Services which should be passed before 03 years after recruitment to the grade III will be held on 2020.04.05 in the medium of Sinhala, English and Tamil. Venue and the time of the examination will be mentioned on the admission card. (All the Grade III officers and those who are required to pass the first efficiency bar examination according to their appointment letter should compulsorily appear for this examination.)

02. Qualifications:

The officers who have got an appointment to a post of saukya karya sahayaka (junior) in grade III Which belong to primary Non – Technical Service Category PL - 01 - 2006 (A) of the Ministry of Health & Indigenous Medical Service are only eligible to apply this examination.

(N:B: Since those who have exceeded three years in Grade III in the post of saukya karya sahayaka (junior) as at 20.07.2012 have been exempted from this examination as mentioned in the General Circular Letter No. 20-90/2015 and the letter dated 12.08.2015 of the Secretary of Health they need not to appear for this examination.)

03. Applications:

Applications prepared by the candidates in accordance with the specimen form of application appended at the end of this circular should be sent by registered post to reach Director (Examinations) Ministry of Health & Indigenous Medicine Services, Suwasiripaya, No. 385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10 on or before 2020.02.28 through the respective Head of Institution. The accuracy of the particulars furnished in each application should be certified by the Head of Division. A self addressed Two (02) envelope (Official or private address) in the size of 9"x4" inches, affixed with stamps to the value of Rs. 45.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

The application in Annexure 1 should be Perfected and sent by the employees under the Line Ministry and the application in Annexure 2 by those who serve in the provincial public Service.

N.B.: If under the Line Ministry, applications be prepared in compliance with the specimen form of application in the size of A4 using in such a way that No: 01 to 04 appear on the first page whilst the No 05 to 07 appear on the second page. 04. Examination Fees:

- Candidates who sit the examination for the first time are exempted from paying examination fees. Other
 candidates should affix stamps to the value of Rs. 25/= per subject in the application and cancel the same by

- II. The examination fees paid will not be transferred to any other examination or refunded under any circumstance.

05. Admission to the Examination:

- Admission cards are issued to the candidates whose applications are accepted. The admission card should
 be duly completed and submitted to the supervisor of the examination centre. Otherwise, it will not be

- Total marks 100. A Candidate should secure atleast 40 marks to pass the examination.

- II. Knowledge on general office systems and Institutional administrative methodologies.
- III. Sufficient Knowledge and proficiency regarding various tasks assigned to the post.
