Second Efficiency Bar Examination for the posts of Control Room Operator, Automobile Technician, Electrician and Cinema Machine Operator for which salary scale PL-3-2006(A) is stipulated of Primary Technical service category – 2020(1st Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by officers in the posts of Control Room Operator, Automobile Technician, Electrician and Cinema Machine Operator of Primary Technical service category for which salary scale PL-3-2006 (A) is stipulated of Ministry of Health & Indigenous Medical Services before expiry of 03 years after promoted to Grade II will be held on 21/03/2020 in the media of Sinhala, Tamil and English. Place and time of the examination will be mentioned on the Admission Card.

02. Qualifications

Only the officers who have got an appointment in Grade II in a post (Control Room Operator, Automobile Technician, Electrician and Cinema Machine Operator) for which salary scale PL-3-2006 (A) is stipulated of Primary Technical service category of Ministry of Health Nutrition & Indigenous Medicine and those who have not yet completed the examination are eligible to apply for this examination.

N.B.:

As mentioned in the General Circular Letter No. 02-90/2015 dated 12.08.2015 of the secretary of the Ministry of Health & Indigenous Medicine Services the officers who have exceeded 3 years in

the Grade II in the posts of Electrician and Cinema Machine Operator as at 27.07.2012 need not appear for this examination, since such officers are exempted from this efficiency bar examination.
