It is hereby notified that the Efficiency Bar Examination which should be passed by Nursing Officers - Grade III before reaching the fourth salary step of the approved salary scale will be held on 16/08/2020 in Sinhala, Tamil and English Medium. The venue and the time table will be mentioned in the admission card.

02. Qualifications

Nursing Officers categorized under Grade III mentioned in the amended Nursing service minute published in the Gazette Extraordinary No 1837/8 dated 19.11.2013 and who have not completed the 1st Efficiency Bar Examination as yet can apply for this examination.

03. Applications

Applications prepared by the candidate in accordance with the specimen form of application appended at the end of this circular should be sent by registered post to reach Director (examination), suwasiripaya, No 385, Rev.
