It is hereby notified that the Efficiency Bar Examination which should be passed by officers in the posts of Control Room Operator, Automobile Technician, Electrician and Cinema Machine Operator of Primary Technical service category for which salary scale PL-3-2006 (A) is stipulated of Ministry of Health before expiry of 05 years after promoted to Grade I will be held on .11.1.12./.2020 in the media of Sinhala, Tamil and English. Place and time of the examination will be mentioned on the Admission Card.

## 02. Qualifications

Only the officers who have got an appointment in Grade I in a post (Control Room Operator, Automobile Technician, Electrician and Cinema Machine Operator) for which salary scale PL-3-2006 (A) is stipulated of Primary Technical service category of Ministry of Health and those who have not yet completed the examination are eligible to apply for this examination.

## N.B. :

## 03. Applications
