Efficiency bar Examination and Departmental Examination for Pharmacists in Grade II/ Seg.II "A" – 2021

It is hereby notified that the Efficiency Bar Examination and Departmental examination which should be passed before reaching the fourth salary step of the salary scale approved for Pharmacists Grade II/ Seg.II "A "will be held in Sinhala Tamil and English Medium. (The Subject related question paper will be prepared only in English Medium) The date, venue and the time of the examination will be notified along with the Admission Card.

02. Qualifications

Only the Officers who have satisfied the requirements rescribed for a post of Pharmacists in Grade II/ Seg.II " A "and not yet completed this examination may apply for this examination.

N.B:- Please take action to send me only the applications of the officers who have satisfied the requirements Grade II as at 31/12/2020.

O3. Applications: - Applications prepared by the candidates in compliance with the form of specimen appended to this circular should be sent under registered cover to reach the Director (Examinations) "Suwasiripaya" No.385, Ven. Baddegama Wimalawansa Thero Mawatha, and Colombo 10, on or before 30/11/2021 through their Heads of Institutions. The Head of Institute should certify the accuracy of contents in each application. Three (03) self- addressed envelopes (Candidates may write their official or private address) in the size of 9" x 4" inches affixed with stamps to the value of Rs.45.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected.

Note: The application should be prepared using an A4 paper based on the specimen form of the application so as to appear the Nos from 01 to 04 on the first front page and from 05 to 09 on the second page. Applications which do not conform to the above specimen will be rejected without any notice.

04. Examination fees:-

- Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/= for each subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.
- Il The fees once paid will not be refunded or transferred to other examinations under any circumstances.

05. Admission to the Examination:-

- I Candidates whose applications have been accepted will be issued with Admission Cards.

 They should submit them to the Supervisor at the Examination center. Otherwise they will not be allowed to sit the examination.
- II Candidates should prove their identity to the Supervisor in the Examination center. For this purpose one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) A formal Identity card issued by the Ministry of Health or relevant institution
 - (c) Valid Driving License
 - (d) Valid Passport

06. Scheme of the Examination:-

This examination consists of two parts viz: Departmental Examination and Efficiency Bar Examination. Departmental examination consists three parts viz: Written, Viva Voce and a Practical and each part are given 100 marks. Minimum 40 marks should be obtained for each part to pass the examination.

Efficiency bar examination consists of two subjects. Establishments Code and Financial Regulations. Each subject is given 100 marks and minimum of 40 marks should be obtained for one subject to pass the examination.

This examination can be completed part by part/subject by subject in one or several sittings. Applicants who sit for the examination for the first time should apply for all subjects.

07. Syllabus of the Examination

07.1.1 Subject related written question paper

Duration for the question paper is 03 hours. The question paper consists of 08 essay type questions and candidates are required to answer any 05 question out of them.

Syllabus

- i. Pharmaceutics
- ii. Forensic Pharmacy (Poisons, Opium and Dangerous drugs ordinance)
- iii. Pharmacology
- iv. Annual estimates and indenting of drugs, dressings, surgical devices and medical gases etc.
- v. purchase of drugs, dressings and surgical devices Locally
- vi. Re-distribution of excess stocks of dated products.
 Disposal of Withdrawn expired and non-moving drugs dressings and surgical device. Disposal of empty containers.
- vii. Procedure applicable for procurement, storage, issuing and accounting of drugs, dressings and surgical devices.
- viii. Procedure on disposal of unserviceable and spoilt drugs dressings and surgical devices.

07.1.2 Subject related Practical Test:-

This is a practical test related to skills and activities relevant to the field. Syllabus of the subject written test is applicable for this also (Duration: according to the test)

07.1.3 Subject related oral Test:-

Syllabus of the subject related written test is applicable for oral and Practical Tests time 15 mints

07.2 Establishments code

Establishment Code is an essay type question paper of 02 hours. Four (04) questions out of 07 questions should be answered. Total Marks given is 100 of minimum 40 marks should be obtained for pass.
