02. Qualifications

03. Applications

Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 2021.12.20 through their Heads of Institutions. The Head of Division should certify the accuracy of contents in each application. Three self addressed envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 45.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected.
