## Third Efficiency Bar Examination for (Legal Officers) belonging to Executive category of Service whose prescribed salary scale is SL - I - 2006 of the Ministry of Health -2020 (1st Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by the Legal officers of the Ministry of Health before expiring five years from the date of promotion to Grade I in the post of Legal officer belongs to Exceutive service of category and the prescribed salary scale of SL- I - 2006 will be held on **09.05.2021** in Sinhala, English and Tamil media. The venue and the time of the examination will be notified along with the Admission Card.

#### 02. Qualifications

Only the officers of the Ministry of Health and Indigenous Medical Services who have been appointed to Grade I in a post of Legal Officer or Chief Legal officer belonging to the salary scale of SL-I-2006 Exceutive service of category and who have not completed the examination upto now can apply for this examination.

N.B: Take necessary actions to send applications of the officers only who has been promoted to Grade I by 30.06.2020 and already received the appointment letter.

#### 03. Applications
