## 02. Qualifications

Only the officers of the Ministry of Health and Indigenous Medical Services who have been appointed to grade II in a post of Legal Officers or chief Leegle officer belonging to Executive category of Service prescribed salary scale for which is SL-I-2006 and the officers who have not completed the examination upto now will apply for this examination.

# 03. Applications
