Efficiency Bar Examination for Grade III Nursing Officers In the Nursing Services – 2021

It is hereby notified that the Efficiency Bar Examination which should be passed by Nursing Officers - Grade III before reaching the fourth salary step of the approved salary scale will be held on in Sinhala, Tamil and English Medium. The date, venue and the time will be mentioned in the admission card.

02. Qualifications

Nursing Officers categorized under Grade III mentioned in the amended Nursing service minute published in the Gazette Extraordinary No 1837/8 dated 19.11.2013 and who have not completed the 1st Efficiency Bar Examination as yet can apply for this examination.

03. Applications

Applications prepared by the candidate in accordance with the specimen form of application appended at the end of this circular should be sent by registered post to Director (examination), suwasiripaya, No 385, Rev. Baddegama wimalawansa Thero mw, Colombo 10 on or before **16/08/2021** through the respective Head of Institution. The accuracy of the particulars furnished in each application should be certified by the Head of Institution. A self addressed 02 envelopes (official or private address) in the size of 9"X4" inches, affixed with stamps to the value of Rs 45.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected.

N.B. The Application should be prepared using an A4 paper based on the specimen form of Application so as to accommodate from number 01 to 04 appear on the 1st page and from number 05 to 10 appear on the 2nd page. Applications that do not comply with the above specimen will be rejected without notice.

04. Examination fees

- I. Candidates who sit for the examination for the first time are exempted from examination fees. Other candidates should affix stamps to the value of Rs. 25/= per subject in the application and cancel them by placing his/her signature and date.
- II. The examination fees paid will not be transferred to any other examination or refunded under any circumstance.

05. Admission to the Examination

- I. Admission cards will be issued to the candidates whose applications are duly perfected. The admission card should be duly perfected and submitted to the supervisor at the examination hall. Otherwise it will not be allowed to sit for the Examination.
- II. Candidates should prove their identity to the supervisor at the examination hall for this purpose. For that, one of the following documents should be submitted.

- a) National Identity Card
- b) A Formal Identity Card issued by the Ministry of Health or a relevant institution
- c) Valid Driving License
- d) Valid Passport

06. Scheme of the Examination:-

The examination consist of two written question papers, and each paper will receive 100 marks. Candidates should score minimum of 40 marks for each paper to obtain a pass from each paper. The examination can be completed at one sitting or at several sittings. At the first attempt officer should apply for all relevant subjects.
