1st Efficiency Bar Examination for the posts of Control Room Operator, Automobile Technician, Electrician, Cinema Machine Operator and for which salary scale PL-3-2006(A) is stipulated of Primary Technical service category – 2021

It is hereby notified that the First Efficiency Bar Examination which should be passed by officers in the posts of Control Room Operator, Automobile Technician, Electrician, Cinema Machine Operator and of Primary Technical service category for which salary scale PL-3-2006 (A) of Ministry of Health before expiry of 03 years after recruitment to Grade III will be held on in Sinhala, Tamil and English medium. The date, venue and time of the examination will be mentioned on the Admission Card.

02. Qualifications

Only the officers who have got a appointment in Grade III in a post (Control Room Operator, Automobile Technician, Electrician, Cinema Machine Operator and) for which salary scale PL-3-2006 (A) is stipulated of Primary Technical service category of Ministry of Health and these who have not yet completed the examination are eligible to apply for this examination.

N.B.:

As mentioned in the General Circular Letter No.02-90/2015 dated 12.08.2015 of the Secretary of the Ministry of Health the officers who have exceeded 3 years in the Grade III in the Posts of Electrician, Cinema Machine Operator & Control Room Operator as at 27.07.2012 need not appear for this examination, since such officers are exempted from this efficiency bar examination.

03. Applications

Applications prepared by the candidates in accordance with the specimen form of application appended to this circular should be sent by registered post to reach "Director (Examinations) Suwasiripaya, No.385, Rev. Baddegama Wimalawansa Thermo Mawatha, Colombo 10, on or before 15/08/2021 through the respective Heads of Institute. The Head of Division should certify that the p-articulars furnished in each application are correct. A self addressed envelope (official or private address) in the size of 9" x 4" inches, affixed stamps to the value of Rs. 45.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

The application in Annexure 1 should be perfected and sent by the employees under the Line Ministry and the Application in Annexure 2 by those who serve in the provincial public service.

N.B.:

The Applications should be prepared using an A4 Paper based on the Specimen from of applications so to recommended From No. 01 to 03 on the 1st Page and from No. 04 to 08 on the second Page Applications that do not comply with the above format will be rejected without notice.

04. Examination fees:-

Minimum 40 marks should be obtained to pass the examination. Duration is one hour
