It is hereby notified that the Efficiency Bar Examination which should be passed by the Legal officers of the Ministry of Health before expiring five years from the date of promotion to Grade I in the post of Legal officer belongs to Exceutive service of category and the prescribed salary scale of SL- I - 2006 will be held on in Sinhala, English and Tamil media. The date venue and the time of the examination will be notified along with the Admission Card.

#### 02. Qualifications

Only the officers of the Ministry of Health and Indigenous Medical Services who have been appointed to Grade I in a post of Legal Officer or Chief Legal officer belonging to the salary scale of SL-I-2006 Exceutive service of category and who have not completed the examination upto now can apply for this examination.
