It is hereby notified that the Efficiency Bar Examination which should be passed by Cardiographers belonging to the Paramedical service Grade III with in three years from the date of appointment to Grade III will be held on in Sinhala, Tamil and English medium. 02. Qualifications

The officers who have been appointed to Cardiographers Grade III, and not yet completed this examination are only eligible to apply for this examination.

03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under Registered Cover to reach the Director (Examinations), "Suwasiripaya", No.385, Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10 on or before 2021.10.29 through their Heads of Institutions.
