

# Efficiency Bar Examination for Grade I Nursing Officers In the Nursing Services – 2020 (2<sup>nd</sup> Term)

According to the Sri Lanka Nursing Service Minute published in extra ordinary gazette notification No 1837/8 and 19.11.2013 dated, it is notified hereby that the Efficiency Bar Examination to be passed within Five years after they promoted to the Grade I Nursing Officers will be held on **14.03.2021** in Sinhala, Tamil and English media. The venue and the timetable will be sent along with the admission card.

# 02. Qualifications:-

- Officers promoted to /absorbed in to Grade I can apply to this Efficiency Bar Examination.
- From the Nursing officers who are absorbed into grade I, the nursing officers who have completed on active Service period of 5 years in Grade I as at 01.11.2010 will be exempted from the 3<sup>rd</sup> Efficiency Bar Examination. And also the nursing officers who are in the posts of Grade I Nursing Officer (Hospital services/Education/Public Health) after following diploma course of 1½ years the post Basic nursing school (National Institute of Nursing Education) will be exempted from this Efficiency Bar Examination. All Nursing officers who are in grade I other compulsory to pass this efficiency bar examination.
- All Nursing officers promoted to grade I after 01.11.2010 should sit for this Efficiency Bar Examination.

N.B: Take necessary actions to send applications of the officers only who has been promoted to Grade I by 31.12.2020 and already received the appointment letter.

## 03. Applications:-

Applications for the Examination should be forwarded on forms prepared by themselves as per format appended to this letter to the Director (Examinations), Suwasiripaya, No 385, Ven Baddegama Wimalawansa Thero Mawatha, Colombo - 10, through the relevant Head of Institutions under registered cover to be received on or before 09.02.2021 The Head of Institution shall certify the contents of every application. Every application shall accompany a self addressed (02) two envelope (may write the official or private address) of 9" x 4", affixed with stamps to the value of Rs. 45.00 and those Applications received late or incorrect and incomplete will be rejected without any information.

N.B.: If under the Line Ministry, applications be prepared in compliance with the specimen form of application in the size of A4 using in such a way that No: 01 to 04 appear on the first page whilst the No 05 to 10 appear on the second page. If in the Provincial Public service application should be prepared using a paper in the size of A4 in such a way that No 01 to 04 appear on first page whilst the No 5 to 10 appear on second page.

# 04. Examination fees:-

- (i) The applicants for the first time will be exempted from exam fees. The others who had applied for but not sat the Examination shall affix stamps to the value of Rs. 25/= per subject in the application and cancel them by placing their signatures and the date.
- (ii) Under no circumstance the fees once paid will be refunded or changed for another Examination.

## 05. Admission to the Examination:-

- 05.1 Admission cards will be issued for properly perfected applications. The applicants should perfect the admission card and hand them over to the supervisor at the Examination. Otherwise they will not be allowed to sit the examination.
- 05.2 The applicants shall establish their identity to the supervisor within the Examination center by producing one of the following.
  - (a) National Identity Card
  - (b) Departmental Identity Card or Valid official Identity card
  - (c) Valid Driving License
  - (d) Valid Passport

### 06. Scheme of the Examination:-

This Efficiency Bar examination consists of two question papers which are **General Management** and **General Nursing.** Duration is 3 hours for each question paper and each paper will receive 100 Marks. Applicants shall secure minimum of 40% marks to have a pass in the Examination. They can complete the examination at once or several occasions. At the First attempt officers should apply for all relevant subjects. (Should Request in the same language applied for the training as a Student Nurse before recruitment of the post.)

Above each paper consist of 08 essay type questions and should answer any 05 questions.
