Third Efficiency Bar Examination for (Legal Officers) belonging to Executive category of Service whose prescribed salary scale is SL-I-2006 of the Ministry of Health -2022 (2^{nd} Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by the Legal officers of the Ministry of Health before expiring five years from the date of promotion to Grade I in the post of Legal officer belongs to Exceutive service of category and the prescribed salary scale of SL- I - 2006 will be held in Sinhala, English and Tamil medium. The date venue and the time of the examination will be notified along with the Admission Card.

02. Qualifications

Only the officers of the Ministry of Health and Indigenous Medical Services who have been appointed to Grade I in a post of Legal Officer or Chief Legal officer belonging to the salary scale of SL-I-2006 Exceutive service of category and who have not completed the examination upto now can apply for this examination.

N.B: Take necessary actions to send applications of the officers only who has been promoted to Grade 1 by 28.12.2022 and already received the appointment letter.

03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under registered cover to reach the Director (Examinations) Ministry of Health, No.385, "Suwasiripaya" Ven. The name of the examination applied for should be mentioned as "Third Efficiency Bar Examination for (Legal Officers) – 2022 (2nd Term) "on the top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self addressed 01 envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application.
