Efficiency Bar Examination for The post in Grade I of primary Non-technical Service Category PL - 01 - 2006 (A) in the Ministry of Health - 2022 (1st Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by the employees in the post belonging to the primary Non technical Service Category PL - 01 - 2006 (A) of the Ministry of Health before expiring five (05) years from the date of promotion to Grade I will be held in Sinhala, English and Tamil medium. The Venue and the time of the examination will be notified along with the Admission card.

02. **Qualifications:**

Only the employees who have been appointed to a post of Grade I in the nontechnical Service category PL - 01 - 2006 (A) (Karyala karya sahayaka, packer, Book Binder, Foot- bicycle Messenger, Watcher, Store Men, Lift operator, photocopy Ronio Machine Operator, Spray Machine Operator, saukya karya sahayaka (Ordinary), saukya karya sahayaka / (junior), in the Ministry of Health, and those who have not completed the examination up to now can apply for this Oral test).

(N:B:- Take necessary action to send applications of the officers only who has been promoted to grade I by .30.03.2022 and already received the appointment letters.

(N:B :- Since those who have exceeded five years in Grade I in the post of saukya karya sahayaka, Book Binder, Watcher, Spray Machine Operator, saukya karya sahayaka (Ordinary), saukya karya sahayaka (junior) as at 20.07.2012 have been exempted from this examination as mentioned in the General Circular Letter No. 20-90/2015 and the letter dated 12.08.2015 of the Secretary of Health they need not to appear for this examination. Furthermore as mentioned of the general circular letter no. 02 - 90 /2015 (p) dated 25.02.2016 of secretary to ministry of health, those who hold the posts such as packer, foot- bicycle messenger, store keeper, lift operator, photocopy ronio machine operator, do not need to pass the efficiency bar examination from the date on which new recruitment scheme was implemented if those past at last one of subjects such as "subject knowledge" or "establishment codes" and "financial regulation" as per old syllabus.

03. Applications:

Applications prepared by the candidates in accordance with the specimen form of application appended at the end of this circular should be sent by registered post to reach Director (Examinations) Ministry of Health, Suwasiripaya, No. 385, Rev.
