Efficiency Bar Examination for the Officers in Grade II of the Post of Speech Therapist belonging to the Service of Professions Supplementary to Medicine (Salary Scale MT-06) of the Ministry of Health – 2022 (1st Term)

It is hereby notified that the efficiency bar examination which should be passed before expiry of three years from the date of promotion to Grade II of the post of Speech Therapist will be held in Sinhala, English, and Tamil medium. The date, venue and time of the examination will be mentioned on the Admission Card. (The Subject Related Question Paper will be issued only in English medium).

02. Qualifications

Officers only who have been promoted to the post of Speech Therapist in Grade II and have not yet completed the examination are eligible to apply for the examination.

N.B.

- Take necessary action to send applications of the officers only who have been promoted to Grade II on or before 09/09/2022 and already received their appointment letters.
- Officers, who have passed the second efficiency bar examination in terms of the old Scheme of Recruitment, should sit the question papers Establishments Code and Financial Regulations in terms of the new Scheme of Recruitment.
- Officers who have failed the second efficiency bar examination in terms of the old Scheme of Recruitment should sit all the three (03) question papers in terms of the new Scheme of Recruitment.

03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under registered cover to reach the Director (Examinations) Ministry of Health No. 385, "Suwasiripaya" Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 09/09/2022 through their Heads of Institutions. The Head of Division should certify the accuracy of contents in each application. Self addressed two (02) envelopes (Candidates can write their official or private address) in the size of 9" x 4", affixed with stamps to the value of Rs. 45.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected.

Note: The application should be prepared using an A4 paper based on the specimen form of the application so as to recommended from 01 to 04 on the first front page and from 05 to 09 on the second page. Applications which do not conform to above will be rejected without any information.

04. Examination fees

- 4.1 Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.
- 4.2 The fees once paid will not be refunded or transferred to other examinations under any circumstances.

05. Admission to the Examination

- 5.1 Candidates whose applications have been accepted will be issued with Admission Cards. They should duly complete and submit same to the Supervisor at the Examination centre. Otherwise they will not be allowed to sit the examination.
- 5.2 Candidates should prove their identity to the Supervisor at the examination hall. For this purpose one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) A formal Identity Card issued by the Ministry of Health or Relevant institution
 - (c) Valid Driving License
 - (d) Valid Passport

06. Scheme of Examination

This examination consists of an efficiency bar examination and a departmental examination. The efficiency bar examination consists of two essay type question papers namely Establishments Code and Procedural Rules and Financial Regulations. The departmental examination consists of Subject Related Written Test, Oral and Practical tests.

07. Syllabus of the Examination

7.1 Efficiency Bar Examination

Seven (07) questions consist in each of these two question papers and four (04) questions should be answered in each question paper. Total marks given for each paper is 100 and minimum 40 marks should be secured to pass each question paper. Duration is two (02) hours.

7.1.1 Establishments Code and Procedural Rules

This question paper is designed based on the following chapters of the Establishments Code and Procedural Rules of the Public Service Commission.

7.2.3 Subject Related Practical Test

This is a practical test carried out on the subject held. A total of 100 marks will be given for this test. This test will carry 100 marks. Fourty (40) marks should be secured to pass the test. Duration varies depending on the test.
