(The Subject Related Question paper will be prepared only in English Medium) The date, venue and the time of the examination will be notified along with the admission card.

02. Qualifications

Officers who have been appointed to a post of Dental Technicians in Seg. II 'A' /Grade II ,and not yet completed this examination are only eligible to apply for this examination.

N.BTake necessary actions to send applications of the officers only who has been promoted to grade II by 15/09/2022 and already received thr appointment letters.

03. Applications

Applications which are received late, incomplete or inaccurate will be rejected.
