It is advised to adhere to the daily timelines for each data entry components:

Component	Timeline
Daily resource review (Aggregate)	10.00 am
Equipment requirement (Aggregate)	10.00 am
Individual case information (Individual)	As and when there is an update to the persons management; should be completed by 12.00 noon
Laboratory Information	5.00 pm
