Annual Transfer of Grade Dental Surgeons 2020- Stage I Appeal

The attached (Annexure I) is the interim list of the stage I of the Annual Transfers of Dental Surgeons 2020.

- 1. All Noted / Eligible officers those who had fulfilled the requirements of selection criteria for Special Posts as stated in the previous communications of even numbered letters D/DS/AT/164/2019 dated 19.09.2019, 23.10.2019 and 02.12.2019 were considered for the stage I of the Annual transfers 2020.
- 2. The transfers were done based on the following criteria:
 - Selection Criteria for HO Posts Should be an eligible officer and not have exceeded ten years (10) in the Government Dental Services. Priority will be given for the officers who apply for the first time. However, if there are no other applicants an officer may be considered for the second term. The general rule that an applicant has to be away from a particular station for minimum of 2 years applies.
 - Selection Criteria for SHO Posts Should have completed HO post for minimum of two year period in the relevant field within immediate past eight (08) years. Those who held SHO posts before the introduction of HO posts also are considered as HOs. Priority will be given for the officers who apply for the first time. However, if there are no other applicants an officer may be considered for the second term. The general rule that an applicant has to be away from a particular station for minimum of 2 years applies.
- 3. The special posts which were not filled during the Stage I transfer schedule are included in the Annexure II. Due to the service exigencies, these vacancies are now open for any noted or eligible Dental Surgeons who are interested in those posts. Transfer board will decide most suitable applicant to the post considering the criteria

- 4. If there are no applicants for any posts under the stage I schedule, those posts will be filled during the stage II schedule
- 5. New posts added and converted due to service exigencies are included in Annexures III & IV. These vacancies are now open for any Dental Surgeons who are noted or eligible.
- 6. As Restorative Units were newly developed in TH Batticaloa and DGH Polonnaruwa, for the HO & SHO Resto posts in these units any Dental surgeons irrespective of their previous transfer orders may apply.
- 7. Please note that once stage I transfers are finalised, those who are given transfer orders will not be considered for stage II of Annual Transfers.
- 8. Officers selected for special posts will not be considered for any other posts or transfers during the period of the special post including PGIM training except for MD program. If an applicant appointed to a post and declines to accept it, he /she will not be considered for special post for another two (2) years. Withdrawal of an application will only be permitted before the closing date of applications for Stage 1 appeal stage.
- 9. Specials claims forwarded with stage I application on medical and personal grounds could only be considered at the stage II appeal stage of the Annual Transfers. Therefore, those who had forwarded their special claims on medical and personal grounds are requested to submit them with a stage II appeal application.
- 10. A web application has been developed for Stage 1 appeal (including new applications for the posts included in Annexures III & IV) of Annual Transfers 2020 and all Dental Surgeons are kindly requested to apply through online application on the website http://dental.hrmis.health.gov.lk/ on or before /7./01/2019. Applicants are kindly requested to send certified hard copy with relevant documentary proof of seniority (grade 1 letter, confirmation letter) through the proper channel.

11. Closing date for stage I appeals is 17 /01/2020
