**Transfers of Specialist Medical Officers End Posts – 2019**

Applications are invited from suitably qualified Specialist Medical Officers for End Posts in the Ministry of Health, Nutrition and Indigenous Medicine and the healthcare institutions under the Ministry.


1. The list of End Posts that are available under different specialities is attached and the applications are called for the End Posts marked as vacant posts.
2. All other end posts occupied by the Specialist Medical Officers are considered as potential vacant posts (as they may get vacant as the officers who occupy such posts are eligible to apply for transfer to another vacant End Post in this list).
3. Only the Specialist Medical Officers who have been promoted to Specialist Grade by the Public Service Commission or the Health Services Committee of the Public Service Commission at the time of application are eligible to apply for the posts in their respective fields.
4. While applying for a transfer is not made compulsory, if wishes to apply, it is requested to apply in the order of their preference.
5. All eligible applicants are hereby requested to submit their application on-line through medserv.health.gov.lk. The online system will be ready for application from 12.09.2019
6. Upon submission of the online application, a print out should be taken for certification by the respective Head of the Institution. The certified application should be sent to the following address via post or fax to reach the office on or **before the closing date which is 24.09.2019.**

7. Applicants should forward their applications from their duly appointed station from the Annual Transfers. Applications will not be entertained if submitted through any station other than his /her due station.
8. The transfers of Specialist Medical Officers in End Post 2019 will be done as per the provisions of the Gazette No: 1176/15 dated 22 March 2001 and the points will be calculated accordingly, up to the closing date of applications.
9. Those who wish to withdraw the application after applying can do so by giving it in writing to Director General of Health Services within two weeks of the closing date. No subsequent withdrawal will be entertained and if the applicant is selected to a post, he / she is compelled to take up the new post.
10. Please note that the undergraduate and postgraduate teaching and training is an important part of the duties of Specialist Medical Officers occupying the End Posts.
11. All applications are considered for vacant posts and potential vacant posts. Please note that only those applicants who applied for end post transfers are eligible to apply for appeal.
12. The officer selected for the post of Consultant Radiologist at the Interventional Radiology Unit, if vacant, should undergo a mandatory training (six months local and six months foreign) within one year of reporting for duty.
13. If a Specialist Medical Officers has an issue with the End Post vacancy list in a particular specialty, it should be informed to the Director/ TCS, Ministry of Health immediately.
14. The Heads of Institutions are requested to bring the content of this Circular to the notice of all Specialist Medical Officers in their respective Institutions.
