- 3. All Specialist Dental Surgeons in OMF who have been promoted to Specialist Grade by the health Services committee of the Public Services Commission by 30/09/2021 are eligible to apply for the posts.
- 4. Specialist Dental Surgeons are requested indicate to their preference order in the application.
- 5. It is not compulsory for Specialist Dental Surgeons to apply for this end post transfers.

No subsequent withdrawal will be entertained and if the applicant is selected to a post, he/she is compelled to take up that post.
