All Specialist Medical Officers who have been promoted to specialist grade by the health Services committee of the Public Services commission by 01/08/2021 are eligible to apply for the posts in their respective fields and applications will not be accepted from officers who claim eligibility pending Public Services Commission approval.

- 10. The end post placement for the year of 2021 which will be effective from 01/08 /2021 will be done per the health services minute appearing in the Government Gazette no. 1176/15 dated 22nd March 2001 and points will be calculated accordingly, up to 31.12.2020.
- 11. Those who wish to withdraw the application can do so by giving it in writing to Director General of Health Services within one week of the closing date. No subsequent withdrawal will be entertained and if the applicant is selected to a post, he/she is compelled to take up that post. Changing of preference order will not be allowed after closing date of application.
- 12. Please note that undergraduate and Post graduate teaching and training is an important part of duties of all specialist Grade Medical Officers occupying end posts.
