- 9. The end post placement for the year of 2023 which will be effective from 01/01/2023 will be done as per the health services minute appearing in the Government Gazette no. 1176/15 dated 22<sup>nd</sup> March 2001 and points will be calculated accordingly, up to 30.11. 2022
- 10. Those who wish to withdraw the application can do so by giving it in writing to Director General of Health Services within one week of the closing date. No subsequent withdrawal will be entertained and if the applicant is selected to a post, He/she is compelled to take up that post. Changing of preference order will not be allowed after closing date of application.
- 11. Please note that undergraduate and Post graduate teaching and training is an important part of duties of all Specialist Grade Medical Officers occupying end posts.
