- 3. All Specialist Dental Surgeons who have been promoted to Specialist Grade by the health Services committee of the Public Services Commission by the **closing date** of the application process are eligible to apply for the posts.
- 4. Specialist Dental Surgeons are requested indicate to their preference order in the application.
- 5. It is not compulsory for Specialist Dental Surgeons to apply for this end post transfers.
- 6. Eligible applicants those who are willing to apply are hereby requested to send their application to the email address ddssonline@gmail.com. Theapplication is available for download at the Ministry of Health website. Application should be submitted on or before documents.com. Applications submitted after the closing date will not be accepted.

No subsequent withdrawal will be entertained and if the applicant is selected to a post, he/she is compelled to take up that post.
