- All the Medical Officers who are on transfer orders on or before 2019, without any approved reattachments
 and who are on transfer orders, must be released to the newly transferred station as soon as possible, as you
 are liable for audit queries for paying the salaries for such Medical Officers without the approval of the
 Secretary Health.
