<u>Collecting Information for Annual Transfers of Grade Medical Officers - 2022</u>

The Ministry of Health is in the process of formulating the noted list to be used for Annual Transfers of Grade Medical Officers 2022 from the Medical Officers who are serving in the Ministry of Health.

Following Medical Officers are to be noted for the 2022 Annual Transfers;

- a) Medical Officers who were released from 2017 or before annual transfer orders.
- b) Medical officers who reported for duty from 2018 Annual Transfers, Special Appeal, North & East and Special List transfer orders before 31st December 2018.
- c) Medical Officers who are currently temporary attached after Foreign Leave, after PGIM studies, and after Secondment Post during last one year period.
- d) Medical Officers who were reinstated in 2018.
- e) Medical officers who reported for duty as per the post intern assignments in 2018.

Medical Officers should serve a minimum active period of two (02) years from the date of reporting for the duty in the current station, if they got the transfer order on or after 2018 Annual Transfer list to be eligible for the noted list as per the instructions given by the Health Services Committee of Public Service Commission letter No. HSC/TRA/MO/14/14/2019, dated 14th January 2020.

Please note that Medical Officers who have completed 2 or more years in a permanent work station, but yet to complete 4 years, are also eligible to apply for 2022 annual transfers. Relevant applications for "Requested to be Noted" can be filled and downloaded from www.hrmis.health.gov.lk and should be submitted to the Heads of the Institution. Heads of the Institutions have to include those names to the noted list through the above link.

The noted list for the Annual Transfers of Grade Medical Officers 2022, will be prepared as an on-line sheet and Heads of the Institutions are requested to login www.hrmis.health.gov.lk for further instructions in this regard. All Heads of the Institutions are requested to submit the details of the medical officers who should be noted (including request to be noted) to the Annual Transfers of Grade Medical Officers 2022, through the link www.hrmis.health.gov.lk, on or before 09th August 2021. Medical officers who want to request to be noted are instructed to download "Requested to be noted" form using the link www.hrmis.health.gov.lk.

Requests of withdrawal of the applications for "Requested to be noted" will only be accepted by a letter **through the head of the institution on or before 11**th **August 2021**. Please note that given transfer orders until 2021 Annual Transfer List, will not be cancelled despite you are completed four or more years in your current station.

Anyone, whose name is not appearing in the noted list, will not be permitted to apply for Annual Transfers 2022. Nevertheless, those who have completed four years in current station without a pending transfer order and fail to inform through the Head of the Institution, will be noted by the Ministry of Health and should consider it compulsory to apply for Annual Transfer 2022.

As per the Public Service Commission procedural rules, all Heads of Institutions should inform the details of all eligible officers and provide correct information as per the schedule to the Directorate of Medical Services, Ministry of Health.
