- 6. Final List of transfer orders will only be released upon consideration of all reviews with the approval of the Public Service Commission.
- 7. It should not be considered that, annual transfer orders given in Annual Transfer final lists 2018, 2019, 2020, 2021 and other Transfer orders are cancelled, with the date of publishing this interim list.
