- 06. Heads of Institutions are responsible to bring the contents of this circular to the notice of all eligible applicants who are currently holding acting appointments temporarily, in their institutions and forward the applications to the department as indicated below.
- 07. The list of vacancies may be amended (posts added or deleted) subject to exigencies of service. Therefore, applicants are advised to mark adequate choices in the applications.
- 08. All eligible applicants are hereby requested to send in their applications via online. The online application is available at medserv.health.gov.lk. The online system will be ready for application form 23.10.2023 onwards until 27.10.2023 date. The closing date and time is 12 midnight on 27.10.2023.
