### Introduction:

Quality-assured, safe and effective medicines, vaccines and medical devices are fundamental to a functioning health system. But globalized trade can undermine regulation, and in resource-limited settings especially, incidence of substandard or falsified medicines is growing. WHO aids countries to strengthen regulation, including post-marketing surveillance, and to eliminate substandard and falsified medicines. It also develops international norms and standards, so that countries worldwide can regulate health products and technologies consistently.

As part of the support of the WHO to strengthen the regulatory capacity of the National Medicines Regulatory Authority (NMRA) of Sri Lanka, in November 2019, the Sri Lankan medicines regulatory body was assessed using the Global Benchmarking tool with identification of an Institutional Development Plan with 299 recommended activities to be fulfilled to reach the recommended maturity level 3. Recommendations include monitoring an evaluation actions to improve the quality of regulatory functions, improve quality of GMP inspections, strengthen pharmacovigilance and market surveillance and to build the capacity of regulators.

It is in this background that WCO-SRL is seeking the services of a Consultant to technically support the strengthening of the monitoring and evaluation of the regulatory functions of the National Medicines Regulatory Authority of Sri Lanka.

## Objectives of the Consultancy:

To strengthen the monitoring and evaluation of the regulatory functions of the National Medicines

## Job Description:

The national consultant is expected to;

- Design a system for audits and conduct periodic audits and reviews to improve overall quality of regulatory functions of the staff
- Design checklists, report formats and feedback forms to improve quality of (i) GMP inspections, both local and overseas (ii) registration dossier evaluations
- Design a mechanism to ensure uniform implementation of policies and harmonization of regulatory actions/decisions of regulatory pharmacists.
- Improve regulatory oversight provided to special molecules (e.g. biosimilars, blood products).
- Conduct identified trainings to improve knowledge of regulatory staff
- Establish a pharmacovigilance system and training of regulatory staff of NMRA on pharmacovigilance activities
- Provide guidance to medicine manufacturers, importers and distributors to establish pharmacovigilance systems in their organizations
- Contribute to the work of WCO on improving access to essential medicines vaccines, diagnostics and devices on primary health care and other related technical work at WHO Country office Sri Lanka.
